#### "ALL CAUSES WITH NOTED EXCEPTIONS" CANCELLATION EXPENSES

Pursuant to the conditions of the cancellation expenses scale

Maximum of €6,000 per person and €30,000 per event

Excess per person

Other reasons: 10% of the amount of the cancellation expenses with a minimum of €75 per person
